Dear Shri Narendra Modi -

I would like to share my concern with you regarding implementation of Indira Awaas Yojana (IAY) in Gujarat.

During 2012/13, the target for the state was 1,36,470 houses of which it is reported that only 99,925 houses were sanctioned. The first installment of Rs.134.24 crore as Central share (75%) was released in the beginning of this financial year. The first installment was released only for 16 districts as the other districts could not avail the second installment during the year 2011/12. Further, during 2012/13, out of 26 districts, we have received proposals for second installment from 11 districts only. Details are enclosed for your reference.

Officials of my Ministry are in active communication with your officers. I request that instructions may be issued to submit all relevant information at the earliest to enable us to release amount due to Gujarat.
